He the said Michael Purkle hath bargained and sold and by these presents doth bargain and sell unto the said James Sampford one hundred acres of land more or less being part of the above mentioned tract of two hundred acres of land laid out unto the said James Sampford as followeth, beginning on a red oak which stands in the line of the above mentioned tract of two hundred acres, on the bank of said Needy River, from thence running N 65° on the said line to the corner on a post oak, from thence running N 40° to Hugh Roarkes line, from thence running on the said Hugh Roarkes line to the said River from thence bounded by the said River down to the beginning including one hundred acres of land more or less, Together with all and singular the Houses outhouses Offices buildings, Barns Stables yards gardens, orchards woods underwoods timber and timber trees, meadows pastures ponds lakes fishings, ways water and water courses, paths passages, liberties, privileges, profits, Hereditaments rights members and appurtenances whatsoever thereunto belonging or in anywise appertaining and the reversion or reversions remainder and remainders, rents issues and profits thereof and every part and parcel thereof. To have and to hold the said tract of one hundred acres of land more or less with every the premises and appurtenances thereunto belonging unto the said James Sampford his heirs Executors Administrators and assigns from the day next before the day of the date of these presents for and during the term ^{and full} of one whole year from thence next ensuing and fully to be completed and ended yielding and paying therefore unto the said Michael Purkle the rent of one pepper corn on the last day of the said term if the same shall be lawfully demanded to the intent and purpose that by virtue of these presents and by force of the Statute for transferring of uses into possession he the said James Sampford may be in actual possession of all and singular the premises above mentioned with every the appurtenances thereunto belonging and thereby be the better enabled to claim and receive the reversion and inheritance thereof which is intended to be to him and his heirs granted and released by the said Michael Purkle by another Indenture intended to be made and dated the day next after the day of the date hereof. This Indenture made the twenty fourth day of April in the year of our Lord one Thousand Seven hundred and Eighty nine, and in the thirteenth year of the Independence of the United States of America, Between Michael Purkle of Greenville County and State of South Carolina planter of the one part, and James Sampford of the County and State aforesaid planter of the other part, Whereas in and by a certain grant bearing date the third day of April one thousand seven hundred and eighty six and in the tenth year of the Independence of the United States of America, from under the hand and Seal of his Excellency William Moultrie Esquire Governor and commander in chief in and over the said State, and the great Seal of the said State for that purpose appointed and give and grant unto the said Michael Purkle a plantation or tract of two hundred acres of land Situate lying and being in the district of Ninety six above the antient boundary line on both sides of Needy River bounding on all sides on vacant land when surveyed and hath such shape form and marks as appears by a plat thereof to the said
