To on Mattocks line 68 Chains to a Stake thence N.E. 19 1/2 links to Stake 3 + thence N.W. 80 on Wm Woods line 63 Chains to said Creek thence down the creek to the beginning being part of a Tract of land Originally Granted to Patrick Lafferty by Grant bearing date the Sixth day of September 1785 and Recorded in Secretary's Office in Book F.F.F. page 41 Reference being thereunto had may more fully appear and from the Said Patrick Lafferty conveyed to the Said Thomas Lewis by lease and Release bearing date the 28th day of November 1787, Together with all and Singular the houses out houses Gardens Tithes woods Orchards commons of Pastures, profits, commodities, advowntages heridaments, ways, waters, water-courses, and Appurtenances whatsoever to the Same Respectively belonging or in any wise appertaining and also the Reversion, & Reversions, Remainder and Remainders Tenths Fees, and Profits to the Same belonging or in any wise appertaining and all the estate Right, Title, Interest claim or demand whatsoever of him the Said Thomas Lewis, of, in, and to the Said Tract of Sixty three Acres of Land (be the Same more or less) and every part and parcel thereof To have and to hold the Said Tract of Sixty three Acres of land and all and Singular the premises above mentioned and every part and parcel thereof with appurtenances unto the Said Jesse Chandler his heirs and assigns to the Only use and behoof of him the Said Jesse Chandler his heirs and assigns for ever and the Said Thomas Lewis for himself his heirs, the Said Tract of Sixty three Acres of Land and every the premises thereunto belonging against him the Said Thomas Lewis, his heirs Executors Administrators shall and will warrant and for ever defend by these presents unto the Said Jesse Chandler his heirs Executors Administrators and assigns from all and every other person or persons whatsoever with warrant and for ever defend In Witness whereof the Said Thomas Lewis hath hereunto set his hand and Seal the day and date first above written.
