

of Pendleton County & State afores^d Witnesseth that the s^r William Right for &
in consideration of the sum of Fifty pounds Sterling to him in hand paid by
the said Laffoon unto the s^r William Right the Receipt whereof he doth hereby
acknowledge hath given Granted Bargained & Sold & by these presents doth free-
ly & absolutely give Grant Bargain sell & Confirm unto the s^r William Laffoon
his heirs & assigns for ever a certain Tract or parcel of Land containing one
hundred acres be the same more or less lying in the County of Greenville
& State afores^d on each side of the north fork of Saluda River Cutting
& bounding as follows on Elias Earle's Land thence & Berry Micham Woods
Land on two sides thence on Samuel Earle's Land & so forth it being part of
a Tract of Land Granted by His Excellency William Moultrie in the year
of our Lord one thousand seven hundred & eighty seven in April with all
woods waters houses Orchards Gardens Fences & all Improvements thereon
being to have & to hold the above mentioned lands & premises with all
