The following deed of conveyance from Martin Gollothan & Nancy his wife to Andrew Jones was produced in open court and acknowledged by the s^d Martin Gollothan & ordered to be Recorded, which was done this 29th March 1791 —

This Indenture made the 19th day of February one thousand seven hundred & ninety one in the fifteenth year of the united States of America between Martin Gollothan of Greenville County of the state S^c Carolina, of the one part & Andrew Jones of the other part of the County & State aforesaid witnesseth that Martin Gollothan for & in consideration of the sum of sixty Pounds to him in hand paid by the s^d Andrew Jones the Receipt whereof the s^d Martin Gollothan doth hereby acknowledge, he the s^d Martin Gollothan hath Granted Bargained & sold Aliened & confirmed & by these presents doth Grant Bargain & sell alien & confirm unto the s^d Andrew Jones his heirs & assigns for ever all that Plantation or Tract of Land containing one Hundred & Twenty three acres of land be the same more or less situate in the County aforesaid on Horse Creek a popular Cotton branch waters of Reedy River beginning on a red oak 37-50 to a stake thence S 80 E to a stake 37-47-50 thence N 16 E to a tree 32-00 thence S 61 W to the beginning Granted on the third day of October Recorded in the Secretarys Office Grant book T^c R^c H^c page Reference being thereunto had may more fully appear; and also all lands Trees, woods under woods & their commons common of pasture profits commodities, advantages & covenants ways waters and appurtenances whatsoever to the s^d Echeuage or Tenements & premises above mentioned belong or in any wise appertaining & also the Reversion and Reversions, Remainders & Remainders Rents & Services of the s^d premises & of every part thereof & also all the estate Right Title Interest Claim & demand whatsoever of him the s^d Martin Gollothan of in & to the s^d plantation or Tract of Land Computed one Hundred & Twenty three acres be the same more or less of every part thereof to have & to hold the s^d Tract of one Hundred & Twenty three acres of Land & all & singular the premises above mentioned with every part & parcel thereof with the appurtenances unto the s^d Andrew Jones his heirs & assigns for ever & the said Martin Gollothan for himself & his heirs & assigns to the only proper use & behoof of him the s^d Andrew Jones his heirs & assigns for ever & the s^d Martin Gollothan for him & his heirs the s^d Tract of one Hundred & Twenty three acres by computation (be the same more or less) with the appurtenances & every part thereof against them & their heirs & against all & every other person or persons whatsoever to the s^d Andrew Jones his heirs & assigns shall & will warrant & for ever defend by these presents In witness whereof the s^d Martin Gollothan hath hereunto set his hand & Seal the day and year first above written.
