


279 The following deed of conveyance from Jesse Chandler to Thomas Mulligan was produced in Open Court and acknowledged by the said Jesse Chandler and Ordered to be Recorded which was done this 4th May 1791

ThisIndenture made the seventh day of February in the year of our Lord one thousand seven hundred and ninety one and of the Independence of the united states of America between Jesse Chandler of the state of North Carolina and of the County of Granville of the one part and Thomas Mulligan of the County & State aforesaid of the other part Witnesseth that the s^d Jesse Chandler for & in consideration of the sum of Twenty Pounds to him in hand paid by the said Thomas Mulligan at and before the sealing and delivery of these presents the Receipt whereof is hereby acknowledged and therefore doth Release acquit & discharge the s^d Thomas Mulligan his heirs Executors Administrators by these presents the s^d Jesse Chandler hath Granted bargained sold aliened & confirmed and by these presents doth Grant bargain sell alien and confirm unto the said Thomas Mulligan and to his heirs & assigns forever a certain Tract or parcel of land situate lying and being in the County & State aforesaid containing by estimation thirty five acres be the same more or less on the waters of Horse Creek Beginning at a post Oak agreed on by the s^d Jesse Chandler & Thomas Mulligan and runs to a sower-wood corner as is mentioned and agreed on and from thence ^{to the} eastwardly to a corner Sycory and runs from thence to a corner Spanish Oak the corner agreed on by said Jesse Chandler & the aforesaid Thomas Mulligan and from thence to the beginning bounded on two sides by Jesse Chandler & William Mulligan and on the other side bounded by a branch of Horse Creek and runs with the water course of said branch it being a dividing line between said Thomas Mulligan
