

The following Deed of Conveyance from Charles Crafford to John Wolff
 being proven before John Thomas Junr. Esq. by the oath of James
 McCaw was presented & Recorded this 16th day of January 1795
 State of S. Carolina, Laurens County This Indenture made this nineteenth
 day of April one thousand seven hundred & ninety four between
 Charles Crafford planter of the one part, of the state afores. & County of
 Greenville, & John Francis Wolff Merchant of the state afores. & County
 of Laurens of the other part Witnesseth that the s^r. Charles Crafford for
 & in consideration of the sum of twenty four pounds fifteen shillings
 to him in hand paid by the s^r. John F Wolff at & before the sealing &
 delivery of these presents the receipt whereof he doth hereby acknowledge
 hath granted bargained & sold & by these presents doth grant bargain
 sell & deliver unto the s^r. John F Wolff his heirs & assigns for ever one
 piece or parcel of land situate lying & being in the state afores. & County
 of Greenville on a branch of Reedy River begining at a light wood
 Stake & runs S 30 W to and oak thence S. 60 E. to a black oak thence
 by a conditional line between Daniel Ford & Abner Burshops to a
 shell bark hickory tree thence up the branch to a white oak station thence
 to the begining containing eighty two acres & a half be the same more
 or less as granted to Abner Burship by Patent bearing date the fifth
 day of June 1786 & from him the s^r. Abner Burship conveyed to the
 s^r. Charles Crafford by a deed bearing date the fifteenth day of March
 in the year of our Lord one thousand seven hundred & ninety one it
 being the fourth part of three hundred & thirty acres of land toge-
 ther with all & singular the premises & appurtenances unto the
 s^r. eighty two acres & a half of land belonging or in any way
 appertaining unto the s^r. John F Wolff his heirs Exors. Adms. & assigns
 for ever to have hold use occupy possess & enjoy without any interrup-
 tion or molestation, & the s^r. Charles Crafford doth hereby covenant &
 agree to & with the s^r. John F Wolff his heirs Exors. Adms. & assigns the
 s^r. piece or parcel of eighty two acres & a half of land to warrant & for-
 ever defend unto the s^r. John F Wolff his heirs Exors. Adms. & assigns or
 from & against the lawful claim or demand of him the s^r. Charles
 Crafford his heirs Exors. Adms. & assigns or from & against the lawful
 claim or demand of any other person or persons whatsoever In
 Witness whereof the s^r. Charles Crafford hath herunto set his hand &
 affixed his seal the day & year first above written
