State of South Carolina This Indenture made the eleventh  
of May in the year of our Lord one thousand seven hundred &  
Ninety Two between Nathan Reed <sup>Nathan Reed</sup> of Greenville County State  
aforesaid of the one part & Horatia Griffin of the County & State  
aforesaid of the other part Witnesseth that the said Nathan  
Reed for & in consideration for & in consideration of the sum of  
Seventy pounds Sterling to him in hand paid by the said Horatia  
Griffin at and before the sealing & delivering of these presents  
the receipt of which the said Nathan Reed doth acknowledge  
& thereof & of from every part & parcel thereof doth acquit &  
discharge the said Horatia Griffin his heirs and assigns and for  
divers other Good causes & considerations hereunto moving have  
granted bargained sold aliened in Enfeoffed and confirmed  
and by these presents doth grant bargain sell alien enfeoff &  
confirm unto the said Horatia Griffin his heirs and assigns for  
ever part of a certain tract of land containing four hundred  
& Sixty nine acres Originally granted to Richard Collins & him by  
his Excellency Thomas Pinckney on the twenty second day of Nov-  
ember 1786 situated in the District of Ninety Six on both sides of  
Gilders Creek the waters of Enoree River beginning on a Chestnut & 3
