The following Deed of Conveyance from James Brazell to Richard Ward being proven before Reuben Barrett Esq^r by the oath of Robt. Smith was presented & recorded this 8th day of April 1795

Lord one thousand seven hundred and ninety four between James
Brazell of Greenville in South Carolina of the one part & Richard
Ward of the County & State aforesaid of the other part witnesseth
that for and in consideration of the sum of fifty pounds Sterling to
him in hand paid by said Richard Ward before the signing sealing and
delivering of these presents the receipt being hereby fully acknowledged
hath bargained and sold and by these presents doth grant bargain & sell
alien confirm release & convey unto the said Richard his heirs Esq^r Adm^r.
& assigns for ever a certain tract or parcel of land containing sevy four
acres more or le situate lying & being on both sides of south Faistate river
Greenville County & State aforesaid begining on a pine + thence N. 70° E.
51 to channel + 82 to black Walnut, then to Mahogany + 8 to White
Walnut N. 12° E small Hickory + 50 to Maple then S 70° E Hickory then E 51 to
Spanish oak then to Stake + then E 12° - 50 to the begining corner Toget-
her with all woods waters rights members & appurtenances whatsoever
to the same belonging, the reversions remainders rights issues and
profits thereof and every part & parcel thereof unto the said Richard
Ward his heirs and assigns for ever to have & to hold the said plantation
tract of land containing 64 acres more or less unto the proper use
and behoof of him said Richard Ward his heirs & assigns for ever
