This Indenture made this eighteenth day of October one thousand  
 seven hundred and ninety four between Abner Senter in Greenville  
 County South Carolina of the one part & Joshua Gozell of the County  
 aforesaid of the other part Witnesseth that for & in consideration  
 of the sum of twenty pounds Sterling Money to him in hand paid  
 by s<sup>r</sup>. Joshua Gozell the receipt whereof is hereby fully acknowledged  
 & that he the said Abner Senter for himself his heirs & assigns hath  
 bargained & sold and by these presents doth grant bargain & sell alien  
 release confirm & convey unto the said Joshua Gozell his heirs, Ex<sup>ors</sup>.  
 Adm<sup>rs</sup>. & assigns for ever, a certain tract or parcel of land containing two  
 hundred acres more or less situate lying and being on a small Branch  
 of Sawtooth River including a large pile of Rocks on Clafuey Mountain  
 having marks & shapes as is described in the plat beginning on a stake  
 at N<sup>o</sup> 25 ft to Dogwood s. N<sup>o</sup> 100 yds s. 80 to Spanish oak s + 6 25 to  
 poplar s, then to Chesnut oak s, then to Chesnut s + N 80 to Chesnut  
 s. E 100 to Sawwood s then to Stake s + 125 to hycory s E 30 to Stake s +  
 85 to B. o. s + 63 to the beginning corner Together with all woods wa-  
 ters water courses and conveniences with all Improvements profits  
 Interests to the same belonging with all the rights members & every  
 part & parcel thereof unto the said Gozell his heirs and assigns  
 for ever to have and to the s<sup>r</sup>. tract of 200 Acres of Land more or less
