

The following deed of conveyance from L. Alston to Jeremiah Stokes  
Sent<sup>r</sup> being proven before Jn<sup>r</sup> Blasingame Esq<sup>r</sup> by the oath of Jon-  
athan Stokes was presented and Recorded this 3<sup>rd</sup> June 1795

This Indenture made this fourth day of May in the year of  
our Lord one thousand seven hundred and ninety five and in  
the nineteenth year of American Independence between Lemuel  
James Alston of the State of S. Carolina & County of Greenville  
the one part, & Jeremiah Stokes Sen<sup>r</sup> of the State and County aforesaid  
of the other part witnesseth that the said Lemuel J. Alston  
for and in consideration of the sum of fifty pounds Current  
Money of the State aforesaid to him in hand well and Truly  
paid by the said Jeremiah Stokes Sen<sup>r</sup> the receipt whereof is here-  
by acknowledged he the said Lemuel J. Alston hath granted  
bargained sold aliened, released conveyed and confirmed by  
these presents doth grant bargain sell alien release convey &  
confirm unto the said Jeremiah Stokes Sen<sup>r</sup> his heirs & assigns for  
ever all that part of a tract of Land containing by computation  
one hundred acres more or less situate lying & being in the State  
and County aforesaid on the small branches of Reedy River it  
being part of a tract of land containing nine hundred acres  
Originally granted to John Goodwyn on the 5<sup>th</sup> day of June 1786  
by his Excellency William Moultrie Esq<sup>r</sup> & Recorded in the Surveyor's  
Office in Book L L L page 79 which said Tract of land  
was executed by the Sheriff of said County sold at public Vendue  
and purchased by the said Alston who now conveys the following  
part of s<sup>r</sup> Tract of the s<sup>r</sup> Jeremiah Stokes Sen<sup>r</sup> viz, Begining at  
a corner called in the Original Grant Brandon's Corner thence N<sup>r</sup>  
30° W 96 chain to a red oak 3x braces corner, thence N<sup>r</sup> 65° E 27 ch 250  
links to a post oak sapling thence S<sup>r</sup> 32° E 52 ch to a black oak 3x an  
agreed on corner between the parties herein concerned, thence a direct  
line across the Original Survey to the begining containing by com-  
putation one hundred acres be the same more or less together  
with all and singular the houses ways wells waters hereditaments  
and appurtenances whatsoever thereunto belonging or any wise  
appertaining, and the reversion and reversions remainder and  
remainders rents issues and profits thereof and every part thereof  
thereof and all the estate right title Interest claim & demand  
whatsoever of him the said Lemuel J. Alston either in law or  
equity to have and to hold the hereby bargained premises unto  
the s<sup>r</sup> Jeremiah Stokes Sen<sup>r</sup> his heirs and assigns for ever without  
any manner of hindrance interruption or denial of him the said  
Lemuel J. Alston his heirs Exec<sup>r</sup> Adm<sup>r</sup> or assigns & lastly the s<sup>r</sup>  
Lemuel J. Alston with hereby warrant and for ever defend the
