This Indenture made this twenty seventh day of March 1794 in the year of our Lord one thousand seven hundred and ninety four. Between John Hunt of Greenville County & State of South Carolina of the one part, & John Barnhill of the County & State aforesaid of the other part Witnesseth that the said John Hunt for & in the consideration of the sum of sixty five pounds Sterling to him in hand paid down by the said John Barnhill the receipt whereof is hereby acknowledged the said John Hunt hath granted bargained sold & confirmed by these presents doth grant bargain sell and convey to the said John Barnhill his heirs & assigns a certain tract of land containing five hundred & sixty acres more or less lying in Greenville County on the North Fork of Brush Creek beginning on a post oak on Flanorys line thence S 62 E to a byer on the Dogan Roost Branch then down the Meanders of S. Branch to Brush Creek then down the meanders of S. Creek to a water oak Marked for a Corner on Mosleys line then S 80 E to a stake of Mosleys, then S 15 W to Stake on Sims line then North 78 W to Sims Stake then S 16 W to post oak then N 85 W to black oak, then to the beginning together with all and every appurtenances thereunto belonging or in any wise appertaining to the only proper use and behoof of him the said Barnhill his heirs & assigns for ever and the S. Hunt for himself his heirs & assigns doth warrant & for ever defend the above mentioned tract of land unto the S. Barnhill his heirs & assigns from all & every other person or persons laying any claim thereunto In witness whereof the said John Hunt hath hereunto set his hand & fixed his seal the day & year first above written
