This Indenture made this twenty seventh day of March 1794 in the year of our Lord one thousand seven hundred and ninety four Between John Hunt of Greenville County & State of South Carolina of the one part, & John Barnhill of the County & State aforesaid of the other part witnesseth that the said John Hunt for & in the consideration of the sum of sixty four pounds Sterling to him in hand paid down by the said John Barnhill the receipt whereof is hereby acknowledged the said John Hunt hath granted bargained sold & confirmed by these presents doth grant bargain sell and convey to the said John Barnhill his heirs & assigns a certain tract of land containing four hundred & Sixty acres more or less lying in Greenville County on the North Fork of Brush Creek begining on a post oak on Flanory's line thence S 62 E to a hickory on the Dugion Root Branch then down the meanders of S. Branch to Brush Creek then down the meanders of S. Creek to a water oak marked for a corner on Mosley's line then S 80 E to a stake of Mosley's, then S 16 W to Stake on Sims line then North 98 W to Sims Stake then S 16 W to post oak then N 85 W to black oak, then to the begining together with all and every appurtenance thereunto belonging or in any wise appertaining to the only proper use and behoof of him the said Barnhill his heirs & assigns for ever and the S. Hunt for himself has heirs & assigns doth warrant & for ever defend the above mentioned tract of land unto the S. Barnhill his heirs Esq^r Adm^r & assigns from all & every other person or persons laying any claim therunto In witness this S.
