The following Eed of bonaryance from James Hide to David Weeks being
 proven before John McElroy Esq^r. by the Oath of John Ford was
 presented & recorded this 13th Day of August 1795,

This Indenture this sixth Day of July in the year
 one Thousand Seven hundred & Ninety Five in the nineteenth year of the
 Independance of the united States of America between James Hide of
 Greenville County & State of S^c. Carolina of the one part & David Weeks
 of the S^d. County & State afores^d. of the other part Witnesseth that the
 S^d. James Hide for & in Consideration of the sum of fifteen pound
 Sterling Money to him in hand & Well truly paid by the S^d. David
 Weeks at & before the sealing & Delivring of these presents the said
 James Hide doth hereby Acknowledge & thereof & of & from
 every part & parcel thereof as quit & Discharge to the S^d. James Hide his
 heirs & assigns & for divers other good causes & considerations hereunto movin
 have granted bargained sold aliened Enfeoffed & Compaigned unto the S^d.
 David Weeks his heirs & assigns forever fifty Acres of Land (more
 or less) lying & being in the County of Greenville lying in the
 W^{est} Branch a branch of Rudy Run being a part
