This Indenture made the Eleventh Day of November in the y^e
 of our Lord one thousand seven hundred & ninety four between
 Mark Forster of Guilford County S^c Carolina of the one part &
 Leonard Claburn of County & State aforesaid of the other part
 Witnesseth that the s^d Mark Forster for & in Consideration of a
 Sum of twenty pounds current money of S^c Carolina to him the s^d
 Mark Forster in hand well & truly p^d by the s^d Leonard Claburn
 the receipt whereof is hereby acknowledged that the s^d Forster ha
 & the Granted bargain'd sold alien'd release convey'd & confirm'd & by
 these presents doth Grant bargain sell alien release convey & confirm
 unto the s^d Claburn his heirs & assigns forever a Tract of Land
 containing one hundred & thirty six Acres Survey'd for Rando
 lph Casy the 14th Day of May 1787 Situate in the District of the
 Georgetown on both sides of the South fork of Tygar River bounded
 S. E. by the s^d Randolph Casy S, 88; by Jas^s Forsters Land
 all other sides by vacant Land with the houses buildings
 Orchards trees woods under woods liches Commons of pastures pro
 fits & advantages hereditaments waters watercourses & Appurtenances
 whatsoever to the same belonging or in any wise appertain
 ing & all the estate right title Interest Powers Claims Dem
