

The following Deed from Joshua Fowler to Richard Jones  
being proven before Jas. Higgin Esq<sup>r</sup> by the oath of Solomon Jones  
was presented & Recorded this 26<sup>th</sup> day of January A.D. 1796

This Indenture Made this 25<sup>th</sup> Day of May on the year of our Lord 1796<sup>r</sup>  
of the sovereignty and independence of the United States of America the nineteenth between  
Joshua Fowler of Pendleton County & State of South Carolina planter of one part & Richard Jones  
of Greenville County and State aforesaid planter of the other part where as in & by a cer-  
tain Grant bearing Date the 7 Day of January 1793 Recorded in grant book E. No. 5  
Page 535 signed by W<sup>m</sup> Moultrie then Governor and commander in chief in & over the  
State did give and grant unto Joshua Fowler a tract of land on Durbin's Creek  
containing 27 acres now this indenture witnesseth that he the said Joshua Fowler  
 hath for and in consideration of ten pound Sterling to him in hand paid by the said  
Richard Jones the receipt whereof is hereby acknowledged bargained & sold  
By these presents both bargain sell aforesaid oves convey and confirm  
unto the said Richard Jones all the above mentioned tract of 27 acres of land situate  
in Greenville County on the waters of Durbin's Creek the waters of Enore river  
beginning at N. R. O. running S. 25° W. 17 ch. to a stake thence S. 65° W. 13 ch.  
to a R. O. thence S. 30° E. 17 ch. to a hukery thence S. 65° E. 15 ch. to the beginning  
to include 27 acres of land as aforesaid together with all & sundry the other  
tenements thereto belonging or in any wise appertaining unto the only proper  
and appurtenant use & be left of him the said Richard Jones his heirs & assigns aforesaid  
he the said Richard Jones his heirs or assigns shall  
occupy possess & enjoy the said plantation or tract of land free and clear from  
any manner of hindrance. Interfere in no way in the administration or denial of his the said Joshua  
Fowler his heirs exec<sup>t</sup> adon<sup>t</sup> or assigns and lastly he the said Joshua Fowler from  
himself his heirs exec<sup>t</sup> adon<sup>t</sup> or assigns or any other person or persons whatsoever  
ever unto the said Richard Jones his heirs executors Nam<sup>t</sup> & assigns of tract of  
27 acres of land aforesaid will warrant & forever defend in writing whereof  
he the said Joshua Fowler hath here unto set his hand seal the day and date  
first above written in<sup>r</sup> Sealed published and delivered in present of - - -

The following Deed of Conveyance from Isaac Mayfield to Ammon  
Gibson being proven before George Salmon Esq<sup>r</sup> by the oath of  
John Mollow was presented & Recorded this 26<sup>th</sup> January 1796

This Indenture Made this 17 Day of December the year our Lord one  
thousand seven hundred & ninety four between Isaac Mayfield and Ammon  
Gibson both of Greenville County & State of South Carolina and ninety  
Sixth District witnesseth that the said Isaac Mayfield for & in consideration
