The following Deed from Zilpha Burch to Tho^s Steat Cavender being proven before Bayles Carle Esq^r of Spartan County by the oath of Suckey Blair was presented & Recorded this 29th day of January 1796

This Indenture made & concluded in 4th Day of October in the year of our lord 1795 between Zilpha Burch of Greenville County & State South Carolina of the one part & Thomas Steat Cavender of the county & State of aforesaid witnesseth that the S^r Zilpha Burch for & in consideration of the Sum of ~~20~~ ^{Twenty} Shillings ^{Starting} to her in hand paid by the said Tho^s Cavender the receipt & payment whereof is hereby acknowledged hath given Grant bargained for & Sold & by these presents doth give Grant bargain for & Sell unto the above ^{named} Tho^s Cavender his heirs Ex^r. adm^r & assigns forever one certain tract of parcel of land situate in the County of Greenville being a part of a tract of acres on the north side of the South fork of Catawba river formerly the property of W^m Clayton & is bounded by lands of Samuel Easley Joseph Maxwell Matthew Harrison Thomas White & William White containing 100 acres less or more together with all the appertinances & privileges thereunto belonging or in any way appertaining with the recursion unto issues & profits to him & his heirs Ex^r. adm^r. & assigns to have & to hold unto him & his heirs until time shall be no more & further agree to warrant & defend the aforesaid title of the S^r tract of one hundred acres of land more or less as above described with the appertinances of the same unto the S^r Tho^s Cavender his heirs Ex^r. adm^r. & assigns against the Claim or claims of himself her heirs Ex^r. adm^r. & assigns of all & every other person ^{or persons} whatsoever in writings whereof the S^r Zilpha Burch hereunto set her hand & affixed her Seal the day & date first above written Sign^d seal & Delivered in the presence of us —
