

The following deed of Conveyance from John Stanford Jun^t to William Grant
being proven before Ruben Barrett Esq^r by the oath of Henry Prince was
presented and Recorded this 18th day of April A.D. 1796

This Indenture made this nineteenth day of September in the year of our Lord
one thousand seven hundred and ninety six and in the nineteenth year of the
American Independence between John Stanford Jun^t of the County of Green-
ville and State of South Carolina planter of the one part, & William Grant
of the same County & State afores^d planter of the other part Witnesseth
that whereas in & by a certain Grant bearing date the fifth day of December
one thousand seven hundred and eighty four under the hand of his Excel-
lency William Moultrie Esq^r Governor and commander in chief in & over the
aforesaid State having the great seal of the State hereunto affixed did give and Grant
unto Randolph Casey the Original Grantee, & then of the County & State aforesaid
and was conveyed by him to the s^r John Stanford Jun^t a tract of land contain-
ing by estimation two hundred acres situate lying & being in Greenville County
in Washington District on the South fork of South Tyger river joining Vacant
land beginning at a red oak and running South $46^{\circ} 6' 44.72'$ to a stake thence $S. 44^{\circ} 44' 44.72'$
 $6^{\circ} 59' 44.72'$ to a post oak thence $N. 40^{\circ} W. 44.72'$ to a stake thence $N. 44^{\circ} 6' 44.72'$ to the
beginning containing the above number of acres the $S. 44^{\circ} 44' 44.72'$ joining
Horn's Land all other sides butting and bounding on Vacant Land at the
time of the Original Survey thereof being made having such form & marks
as are represented by a plat to the s^r Grant annexed which plat & grant being
duly recorded in Surveyor's Office of said State reference hereunto being had
will more fully appear. Now this Indenture witnesseth that the s^r John Stan-
ford Jun^t for the consideration of the sum of two hundred pounds sterling
Money to him in hand paid by the s^r Wm. Grant at or before the sealing or
delivery of these presents the receipt whereof is hereby acknowledged have
granted bargained sold aliened conveyed and confirmed, and by these pre-
sents doth give grant bargain sell alien convey and confirm unto the s^r
Wm. Grant his heirs Exec^t Adm^r & assigns now in his actual possession to have
and to hold the above mentioned tract of Land of two hundred acres &c the
same more or less with all its appurtenances & hereditaments hereunto be-
longing unto him the s^r Wm. Grant his heirs and assigns for ever free and
clear of all Incumbrances from and against the claim or claims of any
person or persons whatsoever the s^r John Stanford Jun^t doth for himself
his heirs or assigns all or either of them & from all & every other person or
persons whatsoever warrant and for ever defend the above described plantation
or tract of land of two hundred acres &c the same more or less unto him the
s^r Wm. Grant his heirs Exec^t Adm^r & assigns for ever In witness whereof
the said John Stanford Jun^t hath hereunto set his hand & affixed his seal
