The following Deed of Conveyance from Joseph Langston to Ragland Langston being proven before John Blasingame Esq^r by the oath of Thomas Edwards was presented and Recorded this 20th day of April 1796
 This Indenture made this sixteenth day of November in the year of our Lord one thousand seven hundred and ninety four between Joseph Langston of the County of Greenville State of South Carolina of the one part & Ragland Langston of the County of the same State of the other part whereas by a certain grant bearing date the fourth day of Feb^r one thousand seven hundred and ninety three from under the hand of his Excellency William Moultrie Esq^r Governor and commander in chief in and over the s^d State having the great seal of the State thereunto affixed being for that purpose appointed did give and grant unto the said Joseph Langston plantation or tract of land containing four hundred and eighty seven acres situate lying in Greenville Co^{ty} on Langstons branch waters of Reedy River and has such form and marks touching & bounding as appears by a plat thereunto annexed which said plat & Grant being duly recorded in the Secretaries Office Grant Book G. N. 5 page 24 reference thereunto being had may more fully appear, Now this Indenture witnesseth that the said Joseph Langston for and in consideration of the sum of fifty pounds Sterling money to him in hand paid by the said Ragland Langston before the sealing & delivering these presents the receipt whereof is hereby acknowledged hath granted bargained and sold and by these presents doth grant bargain & sell unto Ragland Langston all the above described grant of land excepting one hundred and thirty acres more or less sold off to Isaac Wickliff the said Wickliff land beginning at a Red oak Corner below Charles Allens on Richland Creek running thence N. thirty E. fifty three chain 50 links to a Black Gum thence N. 30 chains 50 links to a Red oak thence N. 80 W. to a Red oak Corner in said line near Roberts path, thence along the said path to a hicknut corner in Edwards line thence S. 60 E. 15 chains to a post oak corner in Edwards line thence to the beginning all the rest of the said land as described by plat & Grant unto the said Ragland Langston together with all houses or Charls ways woods waters & water courses profits and emoliments thereunto belonging or in any way appurtenant to have and to hold the said land & premises unto the said Ragland Langston
