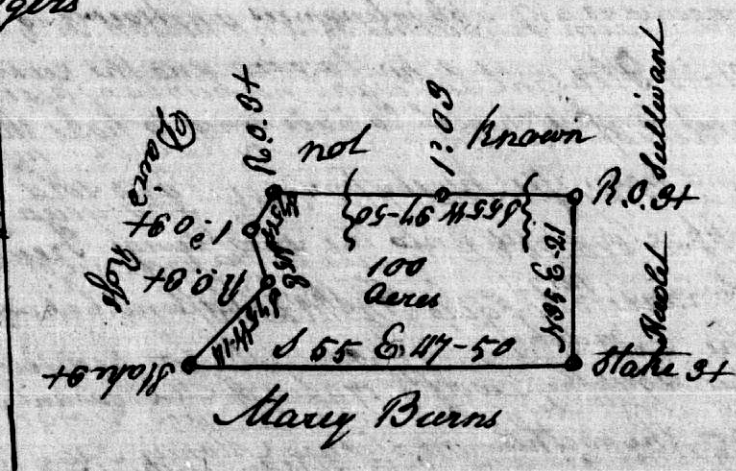


being proven before William Hunter Esq<sup>r</sup> by the oath of Eze<sup>l</sup> Roland  
 was presented and recorded this 10<sup>th</sup> day of August A<sup>d</sup> 1796  
 State of South Carolina this Indenture made the 21<sup>st</sup> day of July one  
 thousand seven hundred and ninety five & in the Twentieth year of the  
 Independance of America between William Wilson of the one part of  
 the County of Laurens of the State aforesaid & Robert Rofs of the other  
 part witnesseth that for and in consideration of the sum of fifty pounds  
 to him in hand well and Truly paid by the said Robert Rofs before the  
 sealing and delivery of these presents the receipt whereof is hereby  
 acknowledged hath granted bargained sold released conveyed & confirmed  
 and by these presents do grant bargain bargain sell release remise con-  
 vey and confirm unto him the said Robert Rofs his heirs &c<sup>o</sup> &c<sup>o</sup> all that  
 plantation or Tract of land containing by estimation one hundred acres  
 more or less lying & being in the County of Greenville & State afores<sup>d</sup>  
 and on Horse Creek waters of Reedy River thatk such shape forme &c<sup>o</sup>  
 as aplat of the same hereunto annexed represents and was granted  
 to William Wilson by his Excellency William Moultrie Governor  
 & commander in chief in & over the State aforesaid on the 20<sup>th</sup> of January  
 1786 & recorded in grant Book B.B.B. in the Secretaries Office page 394  
 Exam<sup>d</sup> &c<sup>o</sup> To have and to hold, the same &c<sup>o</sup> Tract of one hundred acres of land  
 unto him the aforesaid Robert Rofs his heirs &c<sup>o</sup> &c<sup>o</sup> & signs for ever  
 and the aforesaid William Wilson for himself his heirs &c<sup>o</sup> &c<sup>o</sup> all the afores<sup>d</sup>  
 &c<sup>o</sup> Tract of one hundred acres of land with all and singular the premises  
 appurtenances hereditaments &c<sup>o</sup> and all and singular the rites titles (Es-  
 tates) Interest property claim or demand of the afores<sup>d</sup> William Wilson  
 his heirs &c<sup>o</sup> claiming or to claim the same or any part thereof but do  
 as afores<sup>d</sup> give up all claim or title to the same &c<sup>o</sup> Tract &c<sup>o</sup> & do for ever  
 warrant and defend the same from any person or persons whatsoever  
 claiming or to claim the same or any part thereof whatsoever In wit-  
 ness whereof I have hereunto set my hand & seal the day and  
 year first above written
