 hundred & ninety six between Daniel Kelly of Greenville County State
 of S. Carolina of the one part, & Mary Robertson of the County State
 of S. Carolina of the other part witnesseth that for & in consideration of the
 sum of five pounds to him in hand paid the receipt whereof is hereby ac-
 knowledged, the said Daniel Kelly hath granted bargained & conveyed and
 by these presents do grant & convey to the s^r. Mary Robertson her heirs and
 assigns all that tract of land lying & being on both sides Armstrongs creek
 containing one hundred acres being part of a tract Granted by the Statute of
 South Carolina to Sarah White beginning on post oak corner on M^r. Keys line
 thence south to a live oak c^o. on John Cantwell's line thence on James Woods
 line to a conditional pine tree corner thence North to estate on M^r. Keys line
 thence to the beginning to have and to hold the aforesaid land with all the
 appurtenances thereto belonging by her the s^r. Mary Robertson her heirs
