

The following Deed of Conveyance from Isaac Green to William Morgan being proven before Robert M. Afee Esq. by the oath of Isaac Elledge was presented and Recorded this 13<sup>th</sup> day of May AD 1797  
This Indenture made the eighteenth day of March in the year of our Lord one thousand seven hundred and ninety seven between Isaac Green of the County of Greenville State of South Carolina of the one part & William Morgan of the aforesaid State & County of the other part witnesseth that the said Isaac Green for and in consideration of the sum of forty pounds Sterling money to him in hand paid by the s<sup>d</sup> W<sup>m</sup> Morgan (the receipt whereof is hereby acknowledged) he the said Isaac Green hath bargained and sold and by these presents doth bargain & sell unto the said W<sup>m</sup> Morgan a certain tract or piece of land lying & being in Green-ville County on both sides of Mountain Creek of Enoree river contain- ing two hundred & sixty five acres be the same more or less it being part a Tract of land Originally granted to s<sup>d</sup> Green containing two hundred and ninety two acres beginning at a stake Pruning N80 E 22 chain to a pine thence N 79 E 50 links to a red oak thence S 48 C to a red oak thence S 51 W 46 E 50 links to a red oak, thence S 25 W 11 C 50 links to a Sassafras thence S 34 E 9 C to a pepper tree on the bank of the Creek thence S 40 E 7 C 50 links to a hickory thence S 27 W 20 C 75 C to a pine, thence S 10 E 20 C to the beginning it being the part of the a<sup>d</sup> tract bounded on a Survey made for Rob. M. Afee and joining his line but not to go into the same which s<sup>d</sup> tract of land of containing two hundred & sixty five acres be the same more or less with all and every its appurtenances, the said Isaac Green doth from himself and his heirs and from all and every other person & persons will warrant and for ever defend to y<sup>e</sup> s<sup>d</sup> William Morgan his heir and assigns for ever, in witness whereof the said Isaac Green hath hereunto set his hand & seal the day & year above written

The following Deed of Conveyance from John Birdsong to Sarah Kennedy being proven before Ambrose Blackburn Esq. by the oath of Joshua Kennedy was presented and recorded this 26<sup>th</sup> day of May 1797  
The State of South Carolina, I know all men by these that John Birdsong of the County of Orange State of South Carolina South of the Ohio in the State aforesaid in consideration of the sum of fifty three pounds Sterling Money to me paid by Josiah Kennedy Merchant in the State of South Carolina and County of Greenville the said John Birdsong have granted bargained, sold and conveyed and by these presents
