The following deed of conveyance from William Hamby to Henry Cham-
 bliss being proven before Robert McCaspe Esq^r by the oath of Horatia Griffin was
 presented and Recorded this 23rd January 1798

This Indenture made the fourteenth day of March in the year of our Lord
 one thousand seven hundred and ninety seven between William Hamby of the
 County of Greenville and State of South Carolina of the one part, and
 Henry Chambliss of the County of Burk and State of North Carolina of the
 other part witnesseth that the s^d William Hamby for and in consideration
 of the sum of fifty pounds Sterling money to him in hand paid by the said
 Henry Chambliss (the receipt whereof is hereby acknowledged) he the said
 William Hamby hath bargained and sold, and by these presents doth bar-
 gain and sell unto the s^d Henry Chambliss a certain tract or piece of land
 lying and being in Greenville County on branches of Enoree River con-
 taining by estimation two hundred acres be the same more or less it being
 part of a tract of land Originally granted to Ulrich Conner beginning on a
 poplar on a branch whereon the old Meeting House now stands and running
 N^o 25-50 to a Hickery thence N^o 19 E^t 15-50 to a Hickery thence N^o 5 W 9 to a
 red oak, thence N 20-5 to a stake, thence S 13 E to a red oak thence N 85 to a
 pine, thence S. to a post oak corner, thence a marked Conditional line to the
 head of the old meeting house branch, thence down the South side of s^d
 branch to the beginning which s^d tract of two hundred acres of land be the
 same more or less with all and every of its appurtenances the s^d William
 Hamby doth from himself and his heirs and from all and every other
 person and persons will warrant and for ever defend to the said Henry
 Chambliss his heirs and assigns for ever in witness whereof the s^d William
