 one Rubin Barratt Esq^r by the oath of John Stamford ^{was} being presented and
 Recorded this 27th Day of March 1798

This Indenture made Made the twenty ninth day of January one thousand
 Seven hundred and ninety Six between Eschiz Forests of S^c. Carolina
 Greenville County of the one part & George Allin of State & County aforesaid of
 the other part + + + Witness that the said Eschiz Forests for & in consid-
 ration of one hundred pounds Current money of S^c. Carolina to him in hand
 & Well & Truly paid by the S^d George Allin the Receipt + + + +
 Whereupon he by Acknowledged he the said Eschiz Forests hath Bargained
 Sold claimed Received & conveyed & confirmed & by the present doth grant
 the Bargained sell convey & confirm unto the S^d George Allin his
 heirs & assigns forever a tract of Land containing one hundred & fifty acres granted to
 Thomas Lawry Scattered in the district of White tenon a fork of S^c. Sige River
 With all the houses orchid trees Woods Commons Commons of pasture ways waters and appur-
 tenances Whatsoever to the s^d Belonging in any way appertaining & all the estate Right
 title Interest Rights Claims & demands whatsoever of him the said Eschiz Forests in
 & to the said tract of Land Every part thereof to have & to hold the s^d Bargained premi-
 ses above mentioned & all & singular with the appurtenance unto the S^d George
 Allin his heirs & assigns to the only use & behoof of him the said George Allin his
 heirs & assigns forever and he the said Eschiz Forests for himself his heirs & assigns shall
 & will warrant & forever defend from any person or persons whatsoever laying
