The State of South Carolina Know all men by these presents that I Doctan Goodman of Greenville County & State aforesaid in Consideration of one hundred Dollars to me paid by John Salmon of Laswell County state of South Carolina have granted bargained & sold & Released & by these presents do grant Bargain sell & Release unto the said John Salmon a certain tract of Land being & lying in Greenville County, Washington District & on the waters of Reedy River which Land was granted to Isham Foster by his Excellency Benjamin Guiard Esq. bearing date the twenty fourth Day of January one thousand seven hundred & Eighty five which said tract of Land of two hundred Acres or Part thereof being conveyed unto the above mentioned Goodman which he the said Goodman has sold Part of the aforementioned tract of Land unto the said Salmon containing one hundred & forty two acres more or less beginning at Red oak corner adjoining Elias Carter & Formans Land Runing thence N. 20. W. 27 Ch. & 50 Links crossing one Branch twice to a stake at a creek one Pond of Reedy River thence Down the Meanders of said Creek to the original Line thence up the meanders of another Branch to a hickory thence S. 62. W. 12. Ch. to a stake thence S. 22. E. 26 Chs 50 links to a hickory thence N. 57 E. 44 Ch. 75 links to the beginning containing one hundred & forty two acres more or less together with all & singular the Rights members hereditaments & appertinances to the said premises belonging or in any wise Incident or appertaining to have to hold all & singular the premises before mentioned unto the said John Salmon his heirs & assigns forever & do here by bind myself my heirs Executors & administrators to warrant & forever Defend all & singular the said premises unto the said John Salmon his heirs & assigns against myself my heirs & against every other person or persons whomsoever lawfully claiming or to claim the same or any Part thereof in witness Whereof I have set my hand & seal this Sixth day of July one thousand seven hundred & ninety seven & twenty first second year of Free reign Independancy signed in presence of
