 Planter of the other part witnesseth that the said John Clayton
 for and in consideration of the sum of Sixty Pounds Lawful money to
 him in hand well and truly paid by the said John Burk the Receipt
 whereof is here by acknowledged and the said John Clayton fully
 satisfied he the said John Clayton have granted Bargained and sold
 and by these Presents do grant bargain and sell alien Infeoff and
 confirm unto the said John Burk all that Messuage tract or
 parcel of Land situate in the said County of Greenville On Saw her
 Curys beaver dam a branch of the middle fork of Sygar River being
 Part of tract of Land granted to said John Clayton by deed from Wil-
 iam Swift granted to the said William Swift by a grant bearing
