Know all men by these presents that I Joshua Thompson of Greenville County and State aforesaid Plaintiff for and in consideration of the sum of two hundred dollars to me in hand paid by Isaac Bruce of the County and State aforesaid the receipt whereof is hereby acknowledged have granted bargained sold released conveyed and confirmed and by these presents doth grant bargain sell release convey & Confirm unto the said Isaac Bruce and to his heirs and assigns forever all that tract or parcel of Land lying and being in the County and State aforesaid Consisting Branches of Saluda River and branches of Brush Creek waters of Nedy River the same being Originally Granted to James Blasingame the same being Originally Granted to second day of April 1787 & recorded in Secretarys Office in Grant Book W W W W page 1186 upon which the wants had my menfully appear the part thereof hereby meant to be conveyed contains two hundred acres more or less & is as follows viz Beginning on a Stake near a small Branch thence N. 86. W. 21.50 to a post oak & thence N. 25. E. 75. 30 to a Stake & thence S. 70. E. 33 chains to a pine & thence S 70 W. 26.50 to a Black oak & thence N. 83 W 19.50 to a stake thence to the beginning containing two hundred acres more or less I do have and to hold all and singular the premises
