of Greens Creek of S^c Cataula River also 2 3/4 acres in Pinckney
District Spartan burgh County on Camp branch of Lawson's fork
of Cataula River and also all my Estate right title interest
Claim Demand what soever of in and unto the said aforesaid
to one tract of Land and every part and parcel thereof unto
Robert Carter of the County aforesaid his heirs or assigns forever
and also for me and in my name plain & stead and as my propertie
& said to execute seal and deliver such conveyances & assurances of
the said premises unto the said Robert Carter his heirs and assigns

The following deed of conveyance from William Roe to Jordan Jones
being given before Thomas Edwards Esq^r by the oath of George Gil
breath was present to and recorded this 17th day of July 1799
This indenture made this ninth day of March one thousand
seven hundred and ninety nine between William Roe of the State
of S^c Carolina and County of Greenville of the one part and
Jordan Jones of the County & State aforesaid of the other part
witnesseth that the said William Roe for and in consideration of
the sum of two Hundred dollars to him in hand paid the Receipt
and payment whereof Doth here by Acknowledge hath given
Granted & sold and by these presents Doth Give Grant sell & confirm
unto this said Jordan Jones a certain plantation and tract of
Land containing one Hundred acres be the same more or less to
being part of four Hundred acres of Land granted from States
Office to S^cemiah Dutton Bearing date the third day of
November one thousand seven hundred & eighty five and by
S^c S^cemiah Dutton conveyed to John Childers by lease & release
bearing date the twenty third & twenty fourth days of Feb^r
one thousand seven hundred and eighty seven which said lease &
Release is duly recorded in Clerks Office and by said John Childers
conveyed to Charles Bruce by said Bearing date the thirtieth
of September one thousand seven hundred and ninety one
duly recorded also by S^c Charles Bruce to John Standford and
said Standford to W^m Roe and now from William Roe to Jordan
