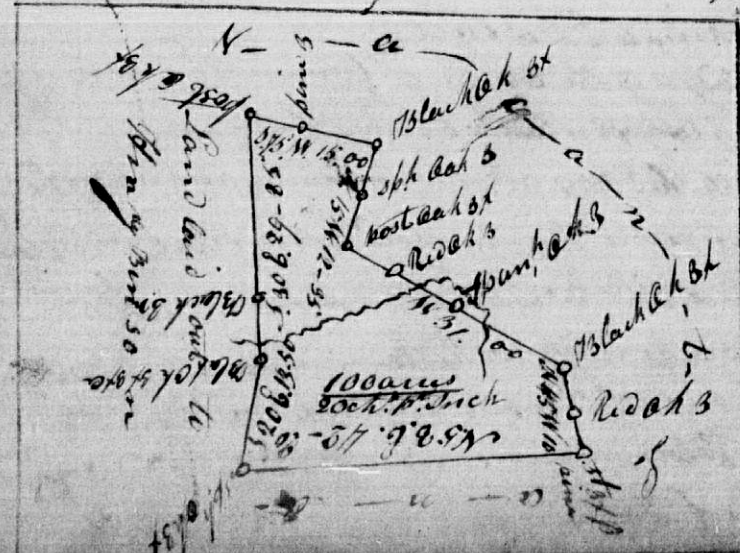


360 The following Grant and assignment on the Grant from Martyn Alkin Solomon Kemp being proven before Neelin Barrett Esq^r by the oath of Aaron Kemp was presented and recorded this 14th day of October 1799

State of South Carolina

To all to whom these presents shall come Greeting
Know ye That for and in consideration of seven shillings and 1/2 Sterling money paid by Daniel Faust into the Treasury for the use of this State we have Granted and by these presents do Grant unto the said Daniel Faust his heirs and assigns a plantation or tract of Land containing one hundred acres (surveyed for Aaron Kemp the 29th of January 1785) Situate in the district of Ninety six west of the ancient Boundary on Bensons branch of Enore river Bounding to the N. E. on Land laid to Henry Benson all the sides vacant having such shape, form, and marks as are represented by a plat hereunto annexed together with all woods, trees, waters, water courses, profits, commodities appertenance and hereditaments what soever therein unto be longing to have and to hold the said tract of one hundred acres of Land and all and singular therein the premises hereby Granted unto the said Daniel Faust his heirs and assigns forever in full and common soverain.

Given under the Great Seal of the State. Witness his Excellency William Moultrie Esq^r Governor and commander in and over the said State at Columbia this fourth day of February Anno Domini one thousand seven hundred and ninety three and of the sovereignty and independence of the United States of America the seven tenth
