one Hundred and nine acres more or less situated in the County  
afores<sup>d</sup> on the Branches of Ready River granted by his Excellency  
Thomas Pinckney unto Thomas Schre & conveyed from him to  
to Abraham Markley & from him to Joseph Bridges recorded in the  
Secularys Office Grant Book P P P page 313 & Boundaries  
followeth Beginning at a Post Oak Corner the Original Line  
Running thence N. 30 E. 30 Ch<sup>s</sup> to a Hickory in the dividing line  
thence S. 70 E. 17 Ch<sup>s</sup> to a stake thence S. 30 E. 15 Ch<sup>s</sup> to a Locust  
thence S. 10 W. 24 Ch<sup>s</sup> & 60 Lt<sup>s</sup> to a Hickory thence S. 70 W.  
38 Ch<sup>s</sup> to the Beginning containing one hundred and nine  
acres more or less Together with all & singular the Rights members  
Appertinements & appertinances to thes<sup>e</sup> premises Belonging

Holcomb being proven before Reubin Barlett Esq<sup>r</sup> by the oath of Hinckin  
Holcomb was presented and recorded this 19<sup>th</sup> day of December 1799  
South Carolina  
I now all men by these presents that Jordan Holcomb of Greenville Co<sup>ty</sup>  
& State afores<sup>d</sup> in consideration of the sum Two hundred dollars to me  
paid by Littleberry Holcomb of s<sup>d</sup> County & State afores<sup>d</sup> have granted Bargain  
ed & sold the least unto the s<sup>d</sup> Littleberry Holcomb a plantation or tract  
of Land lying and being in Greenville County & State afores<sup>d</sup> being part  
of a tract of Land where on the s<sup>d</sup> Jordan Holcomb now lives being  
granted to the s<sup>d</sup> Jordan by his Excellency <sup>Gen. Moultrie Esq<sup>r</sup> Governor</sup> & Commandeur Chief Beginning on a Red Oak Corner in Thomas  
Bartons Land Running S. 15 E. 30 to a white oak thence E. to  
a Red Oak station agreed on for a corner thence a Crook to a post  
oak on the a thus side of the Land a Line on by both parties to be  
the Corner thence a long the original Line to the beginning Corner  
on the Red Oak supposed to be one hundred acres more or less Together  
with all and singularly the wrights members Appertinements  
an appertinances to the same premises be longing or in any  
wise appertaining to have and to hold all and singularly the  
premises be fore mentioned unto the s<sup>d</sup> Littleberry Holcomb  
his Heirs and assigns forever and do hereby Bind myself  
my Heirs Executors administrators and assigns & every of them  
to warrant and forever defend all and singularly the premises  
be fore mentioned unto the s<sup>d</sup> Littleberry Holcomb his Heirs  
& assigns forever & agt all & every other person Claiming or  
to claim the same or any part thereof. In witness where of  
the said Jordan Holcomb have hereunto set my hand and  
affixed my seal this twenty seventh day of February in the  
year one thousand seven hundred and ninety nine and in the  
twenty fourth year of our nations Independance  
Signed seal<sup>d</sup> and delivered this day in the presents of us the wit-  
nesses & it is supposed one acre of this Land lies in Bartons tract if so  
Hinckin <sup>his</sup> Holcomb <sup>mark</sup> to be accountable for that one acre the High Sheriffs
