

374 The following deed of Conveyance from Hinchen Holcomb to Jordan Holcomb being proven before Reubin Barnett Esq by the oath of William Hood was presented and recorded this 18th day of the 2nd 1799

Know all men by these presents that Hinchen Holcomb of the state of Carolina & County of Greenville in Consideration of the sum of one hundred & fifty Dollars to me paid by Jordan Holcomb of the state and County afores^d Grant Bargained & sold and Released unto the s^d Jordan Holcomb a plantation or Tract of Land lying & being in Greenville County & State afores^d Beginning on a corner agreed Corner between s^d Hinchen Holcomb & Henry Bates thence to a marked Beach on the Creek called Bartons fork of Tiger River thence on to a stake Corner thence along the original line to a stake thence a Cross the Creek to a Spanish Oak on the top of a Hill thence on to a stake on the original line thence along the old line of Lynch to the beginning supposed to be sixty acres of Land be the same more or less the same being part of a tract of Land granted to W^m Davis & by W^m Davis conveyed to John Davidson then John Davidson conveyed the afores^d mentioned part to the said Hinchen Holcomb. Together with all and singularly the rights members Accidents & appertinances to the same premises belonging or in any wise appertaining to have and to hold all and singularly by the premises before mentioned unto the s^d Jordan Holcomb his heirs and assigns forever and I do here by being myself my heirs be^{ts} adm^{rs} & assigns & every of them to warrant and forever defend all and singularly the premises afores^d unto the s^d Jordan Holcomb his heirs and assigns forever & against all & every other person or persons Claiming or to Claim the same or any part thereof I with myself whereof the s^d Hinchen Holcomb have hereunto set my hand and affixed my seal this twenty seventh day of February

The following deed of Conveyance from Overton Goodman to William Anderson being proven before Reubin Barnett Esq by the oath of Joseph West was presented & recorded this 21st day of December 1799
This Indenture made the Twenty fifth day of September one thousand seven hundred and ninety nine Overton Goodman & Mary his wife of the one part & William Anderson of the State of Carolina & Greenville County of the other part Witnesseth that for and in consideration of the sum of Four hundred & Fifty Dollars to me the s^d Goodman in hand paid by the s^d Anderson and the Receipt whereof is here by fully acknowledged & the s^d Goodman fully satisfied for the same I have Bargained sold allined & Confirmed unto the s^d William Anderson a plantation or tract of Land By Two hundred acres more or less being the Lower half of a four hundred acre Tract of Land granted unto Archabald Dill by a Grant bearing date the First day of January one thousand seven hundred and eighty five & by s^d Dill conveyed unto John Russell & by s^d Russell conveyed to s^d John Russell conveyed to John Standford & from s^d Standford to s^d Overton Goodman & it is Bounded as follows beginning on a Red Oak Corner on Henry Pines line running N^o 30 W^o 55 6 chain to a Red Oak thence S^o 60 E^o to Red Oak a ground Major Gowen & James Cope land when the s^d Tract was Divided running thence a long & agreed line which runs at or near s^d Cope land's fence to an agreed on Chesnut from thence Down s^d Creek first on one side and thence the other to the beginning Corner. Together with all and singularly the premises with members Accidents & appertinances to have & to hold all and singularly the s^d premises above mentioned to the s^d William Anderson his heirs & assigns forever we here by bind ourselves our heirs & Executors Administrators and assigns against all and every other person & persons with warrant and
