 cock of the City of Charleston in the State of S^c Carolina
 Vendor Master of the one part and Andrew Vos of the
 said City and State Merchant of the other part Witnesseth
 that the said Job Colcock for and in consideration of the sum
 of Five shillings to him in hand well and truly paid by the
 said Andrew Vos at or before the sealing and delivery of these
 presents the Receipt whereof is hereby acknowledged hath
 Granted Bargained and sold and by these presents doth Grant
 bargain and sell unto the said Andrew Vos his Executors
 Administrators and assigns all that plantation or tract of
 Land containing Three hundred acres situate in the district
 of Ninety six on Saluda River in the state aforesaid and hath
 such Shapes form and Marks as are Represented in a plat
 thereof annexed to the original grant to the said Job Colcock
 dated the third day of April in the year of our Lord one
 thousand seven hundred and eighty six and Recorded in the secre-
 taries office of this State in Grant Book S.S. page 74
 as in and by the same may more fully appear also all that
 plantation or tract of Land containing Three hundred acres
