 a white oak stake thence S^o 50 W^o 6 Chains to a white oak Corner thence S^o 50
 to a stake thence N^o 66 E^o 3^o Chain to a stake thence N^o 16 E^o 56 Chain 80 Links to
 the beginning and hath such shape and marks as may appear by a plat to the
 same originally surveyed for Captain Ellis and Granted to Job Colcock the

 Beginning on John Statten's line on river Running up the Creek to
 the Mouth of the Oil Camp Creek thence up the Creek to the South point
 to a white Oak on the Creek a conditional Corner from thence a Condi-
 tional Line to a dogwood Corner on the old original line thence along
 the old line to the river to the Beginning per Compliment fifty acres more or
 Less Together with all and singular the Rights, members hereditaments and
 appurtenances to the said premises belonging or in any wise incident or
 appertaining to have and to hold all and singular the granted premises as
 before mentioned unto the said John Statten his heirs and assigns for
 ever and do hereby bind myself my heirs and assigns for
 tors to warrant and for ever defend the same granted premises unto
 the said John Statten his heirs and assigns against myself my heirs
 and assigns and against every other person whomsoever Lawfully
