Carolina Greenville District Know all men by these Presents that I Robert Prince for and in consideration of the sum of One hundred dollars to me in hand paid by John Arrasmith the Receipt whereof is hereby acknowledged hath granted bargained & sold & by these Presents do grant bargain sell and release unto John Arrasmith of the District and State of aforesaid ~~Twenty five~~ Acres of Land, more or less out of a large Survey of four ~~thousand~~ thousand Acres granted to the s<sup>r</sup> Robert Prince by his excellency Thomas Pinckney bearing date the 10<sup>th</sup> day of November one thousand seven hundred and Eighty Six - beginning on a Pine Corner near a branch running thence to John Snoddy's ~~line~~ Black Oak Corner, thence along Snoddy's line to Tankersly's line to a Post Oak Corner of Perry's land, thence to the beginning containing Seventy Acres more or less, To have and to hold all & singular the Premises before mentioned with all and singular the rights members hereditaments and appurtenances unto the s<sup>r</sup> John Arrasmith & his heirs forever. And I do bind myself my heirs &c. for ever to warrant & defend the above mentioned "Premises" to s<sup>r</sup> Arrasmith & his heirs against myself & my heirs & against every other person or persons lawfully claiming or to claim the same or any part thereof.
