 Minshew of District aforesaid have granted bargained sold & released and by these presents do
 grant bargain sell & release unto said Minshew part of a tract of land originally granted to
 Abdiash Hooper, lying on the North branch of conroe river beginning on a black oak
 on the east side of the Cattail branch running thence down the side branch to a poplar
 corner thence up a glade to the head to a station pine thence to a conditional pine corner
 thence a long the conditional line made by sd Landreth & Minshew to a road thence the said
 road to the line thence the line to the beginning fifty acres more or less together with all &
 singular the rights members hereditaments & appertinances to sd land premises belonging
 or in any wise in dent or appertaining to have & to hold all & singular the premises
 before mentioned unto the sd Minshew his heirs & assigns forever and I do hereby bind
 myself my heirs Executors & administrators to warrant & forever defend all & singular the sd premises
 unto sd Minshew his heirs & assigns against myself my heirs & assigns & every other person
 or persons whomsoever lawfully claiming the same or any part thereof
