

The State of South Carolina Know all men by these presents that I James Tarrant of Greenville District & State aforesaid for & in consideration of the sum of Four hundred & thirty four Dollars ninety two cents & a half to me paid by Thomas Paine of the same Place hath Granted bargained sold & delivered & by these presents Do Grant bargain sell & release unto the said Thomas Paine one certain tract or parcel of Land containing eighty five & one third Acres situated in Greenville District on the Golden Grove Creek it being part of a tract of Land Originally Granted to John Bowie beginning at a white Oak corner on Isaac West's line and running on Matthias Purchasons line 27 ch⁶ 11 to a white Oak corner on a branch thereof 13⁶ 60 with said line to a sweet gum corner on the Grove Creek and thence 29 Down said creek to a white Oak corner & from thence 23⁶ to a red Oak corner on Isaac West's line & from thence 27⁶ to a corner stake & from thence 26⁶ to the beginning and Likewise a certain tract or parcel of Land situated in Greenville District on a branch of the Golden Grove Creek containing forty acres more or less it being part of a certain tract of Land Granted unto John Bowie Beginning on a corner white Oak on Isaac West's line & thence N. 23⁶ E. 17⁶ to a corner stake and thence N. 58⁶ W. 29⁶ to a corner stake on the Original line & thence S. 44⁶ W. 13⁶ to Isaac West's corner stake & from thence to the Beginning for the consideration of two hundred & three Dollars 88 Cents. Together with all & singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise Incident or appertaining To have and to hold all & singular the premises before mentioned unto the said Paine his heirs & assigns forever and I do hereby bind myself my heirs Executors and administrators to warrant & forever defend all & singular the premises aforesaid unto the said Thomas Paine his heirs & assigns against myself & my heirs & against all other persons or persons who ever lawfully claiming or to claim the same or any part thereof - Witness my hand this twenty seventh day of Nov^r 1804 and in the twenty eighth year of the Independence of the United States of America
