Doeg by a grant bearing Date the twenty first day of January A.D. one thousand seven hundred & Eighty five, said part of said Deed to be one hundred and six acres (be the same more or less), Beginning at W<sup>m</sup> Ross part of the said Deed and running South West to a post Oak Corner thence Running N.W. to a white Oak Corner thence N.E. to a black Oak Corner thence N.E. to a Hickory, or part of that said Line. that does Corner on said Hickory thence runs the dividing Line between W<sup>m</sup> Ross's part and said Deed, which aforesaid of said Deed of one hundred and six acres of Lands (be the same more or less) - The said Michael Miller Do Warrant and former Defendant the above mentioned Deed of Lands of one hundred and six acres (be it more or less) - to the said W<sup>m</sup> Ross his heirs and assigns &c. Free and clear from me my heirs and assigns &c. and from all and every persons or persons whatsoever Laying any legal claim to the same -

State of South Carolina, Know all men by these presents that I John Hollands of Greenville District in the State aforesaid in Consideration of Two hundred Dollars to me paid by W<sup>m</sup> Taylor of the District State aforesaid Have Granted bargained sold and Released, and by these presents Do Grant bargain sell & Release unto the said W<sup>m</sup> Taylor a certain tract of Lands Lying and being in the District and State aforesaid, on the waters of Bushy creek of Enore River Containing Two hundred acres more or less, it being a part of a tract of Land Originally granted to John Campbell, Whereas it Beginning on a post Oak thence Running N. 19. E. to a Stake on Corners old Line, thence S. to a post Oak From thence E. to a Stake on Dan<sup>l</sup> Abney's Line from thence to the Conditional Corner made between John Campbell & Dan<sup>l</sup> Abney from thence running down the Branch to William Fergusons Land from thence tuning S. 56. W. to a post Oak thence N 20. E. to a post Oak -
