I HAVE granted bargain sold & released and by these Presents do grant bargain sell & release unto the said Blackman Lyon all that tract or parcel of land, situate lying & being in the District of Greenville aforesaid on Saluda River, containing two hundred & twenty five acres, be the same more or less, being all that tract or parcel of lands originally granted to William Benson by his Excellency William Moultrie the 5th day of June 1786, as appears by a grant recorded in the Secretary's office in Grant book 16. 16. 16. page 781. which said tract was laid off and allotted to me by Commissioners for that Purpose appointed by the Court of common Pleas of Spartanburghs district as one of the Heirs of the saids William Benson deceased, Begining on a crabapple tree corner on Saluda river, thence S 75. E. 14 to a hickory thence N. 73. E. 10. 50 to a post oak, thence S 55. E. 45. to a Stake by a black oak. thence S. 55. W. 55. 70. to a Stake by a white oak. thence up the meanders of the river to the Beginning, Together with all & singular the rights members hereditaments & appurtenances to the said Premises belonging or in any wise Incident or appertaining, To have and To hold all & singular the Premises before mentioned unto the said Blackman Lyon his heirs & assigns forever: And I do hereby bind myself my heirs Executors & administrators to warrant & forever defende all & singular the Premises above mentioned unto the said Blackman Lyon his heirs & assigns against myself, my heirs and against any other Person or Persons whomsoever lawfully claiming or to claim the same or any part thereof — Witness my hand and seal this (fourteenth)
