I know all men by these presents that I Joab Smith of the state of Kentucky, Warren County, for and in consideration two hundred & fifty Dollars to me in hand paid, Have granted bargained and sold and by these presents Do grant bargain & sell & Release unto Pink Hawkins Junior of the state South Carolina and Greenville District, one certain tract or parcel of land containing by survey one hundred acres Bounded as follows Viz: Beginning on red oak, thence North 82^o E 32^o N. to stake N. 68^o W. 31^o 38' to stake by R. P. O. S 22^o W. 32^o to red oak thence to the Beginning, it being part of a survey of six hundred & forty acres conveyed from James Langston to Solomon Langston as the records of Greenville will make appear situated in Greenville District on both sides of Langston's creek, Together with all & singular the rights members hereditaments and appurtenances to the said Premises belonging or in any wise incident or appertaining - To have and To hold all and singular the Premises before mentioned unto the said Pink Hawkins his heirs and assigns forever - AND I do hereby bind myself my heirs &c. To warrant and for ever defend all and singular the said Premises unto the said Hawkins his heirs and assigns against myself my heirs or any other Person or Persons lawfully claiming or to claim all or any part thereof - Witness my hand and seal this 14th day of December one thousand eight hundred and five and of American Independance the 30th year - Signed Sealed and Delivered in Presence of } - Joab Smith
