in the year of our lord one thousand eight hundred and five, and in the thirtieth year of the Independancy of the united States of America, Between William Tubb Senr, of the aforesaid State, and District of Greenville of the one part, and Jeremiah Tubb of the State and District aforesaid of the other part. Witnesseth that the said William Tubb Senr

for and in consideration of the sum of two hundred Dollars to him in hand paid by the said Jeremiah Tubb the receipt whereof is hereby acknowledged, HAVE granted bargained sold and Released, and by these presents DO Give Grant bargain sell & deliver unto the said

Jeremiah Tubb his heirs and assigns all that tract or parcel of land situated in the District aforesaid on both sides of Enoree River Bounded by lands belonging to Enock Benson on S^o side of said of S^o river, and land belonging to Humphrey Toosey on the W^o side of S^o river, & by land originally granted to Talbot on the N^o side the same containing two hundred and twenty three acres, it being a tract of land originally granted unto

John Tumbough Senr dated the fifth day of June one thousand seven hundred & Eighty Six, as appears from a plat annexed to said Grant, To have and to hold the above granted land with their appurtenances and Hereditaments thereunto

belonging unto him the said Jeremiah Tubb his heirs and assigns forever free and clear of all Incumbrances & from & against the claim or claims of any person or persons whatsoever the said William Tubb doth for himself his heirs & assigns all or either of them, do warrant and forever defend the above granted and bargained Premises with its appurtenances unto him the said Jeremiah Tubb his heirs and assigns forever
