State of South Carolina, Know all men by these presents that I William M^r Clure of Greenville District, in the State aforesaid, Have made, ordained, authorized, Constituted and appointed, and by these presents do make, ordain, authorize constitute & appoint, Thomas Butler of Buncombe County in the State of North Carolina, my true and lawfull attorney for me, and in my name, and to use, to sue for recover, & receive in all lawfull actions & causes of actions in Law & Equity, which I now have or hereafter may have, against Eli Langford of touching and concerning any suits now brought or which I may hereafter have or bring, against the said Eli Langford of and concerning, a certain plantation and tract of lands of which the said William M^r Clure hath been dispossessed by the Sheriff of Buncombe County aforesaid, as well for & on account of said ousting, as for said Langford's forcible Entry, & possession, of the said plantation and the premises thereon and his forcible detainure of the same, and also to bring action or actions against all and every other person and persons who may have aided and abetted the said Langford in the forcible Entry and detainure of the said plantation & the premises thereon, And I the said William M^r Clure do hereby also authorize my said attorney for me and in my name to defend me in all actions that may be hereafter or now are brought against me for or touching or concerning the above said Plantation and premises either in Law or Equity, and to do all lawfull acts and things whatsover, concerning the Premises, as fully in every respect, as I myself might or could do, if I were personally present, and an attorney or attorney under him for the purposes aforesaid, to make, and at his pleasure to work hereby ratifying, allowing, and confirming all and whatsoever, my said attorney shall in my name
