by John Davis of the district aforesaid, I have bargain sold and Released &
by these presents do Grant bargain sell and Release, unto the said John Davis a
plantation or tract of land, lying and being in Greenville District on the waters of Tyger
River on both sides of neals fork of said river, bounding all sides by vacant land Begin-
-ing on a Stake Running W. 36. 5. to a red oak, thence N. 36. 5. to a stake thence E. 36. 5. to a
Stake, thence S. 36. 5. to the Beginning, corner on a stake, containing by Estimation one
hundred and thirty acres more or less. the same being a tract of land granted to the said
Arthur Barrette by a patent bearing date the twenty third day of August in the year
one thousand seven hundred and ninety two under the hand of Charles Pinckney
Esq. then Governor of said State. Together with all and singular the rights members
hereditaments and appurtenances to the said premises belonging or in any wise appertain-
-ing. To have and To hold, all and singularly the Premises before mentioned to the said
John Davis his heirs and assigns forever, and I do hereby bind myself my heirs Executors &
administrators to warrant and forever defend, all and singular the said premises unto
the said John Davis his heirs and assigns against myself and my heirs and against every person
whomsoever Lawfully claiming or to claim the same or any part thereof, In Witness whereof
I have hereunto set my hand and seal, twenty ninth day of April in the year of our
Lords, one thousand Eight hundred and two and in the twenty sixth year of Amer-
