Walker of the district aforesaid, the Receipt whereof is here by Acknowledg^d, I have granted bargained and sold unto the said andrew W. walker a Certain tract or parcel of Land lying and being in the district and State aforesaid on the waters of Chicharaah River on the waters of the North fork of Saluda River having such boundaries as here after mentioned begining on a pine tree on Roberts Cokes Line running an East Course to the mouth of a branch Called the Still hours branch and Crossed on a white oak thence up the said branch to John Gowens land, this being a Conditional line betweene myself and said walker, thence Binding on John gowens and Williams Cornains Lands, on the North thence binding on said Walkers original line Dennis duff^s and Roberts Cokes on the west, to the begining Corner, the said Conditional line binding on the South and East, Containing by Estimation One hundred and fifty acres be the same more or less which said tract or parcel of Land which was granted to me the said William Lynch by his Excellency Edward Rutledge Governor and Commander In Chief in and over the said State this ninth day of may in the year of our Lord one thousand seven hundred and Ninety nine I do hereby warrant and forever defend all and singular the said premises unto the said andrew W.
