E. 17. 50 to a red oak 3<sup>+</sup> bounding on the said David Franums land thence S. 60. W. 38. 50 to a hickory 3<sup>+</sup> bounding on the aforesaid D. Franum thence N. 30. W. 17. 50 to a Stake 3<sup>+</sup> bounding on Benj<sup>a</sup>. Arnolds land thence Running the different courses of William Franums line to the Beginning, reserving 50 links on each side of horse creek through the said tract - Together with all and singular the rights members hereditaments and appurtenances to the said Premises belonging or in any wise incident or appertaining - To Have and To Hold all and singular the Premises above mentioned and Released unto the said William Franum his heirs and assigns forever.
