State of South Carolina, Know all men by these presents that I Nathaniel Gentry of Greenville District in consideration of the sum of three thousand dollars to me paid by John Gowen of Spartanburgh District, Have granted bargained sold & released, and by these Presents do grant bargain sell and release unto the said John Gowen a plantation or parcel of Lands in the District of Greenville afores^d on both sides of Green's creek of South Picolett River Beginning at an agreed corner made by Richard Brasell & David Hall, at a red oak near a branch thence N. 48. 10. to a post oak, thence S. 50. W. 15. to a post oak, thence S. 15. to a white oak thence E. 22. to a Red oak, thence down a branch to the creek, thence up a branch north to the Beginning, containing Fifty acres be the same more or less being granted by patent bearing date 5th June 1786, unto William Lynch and by him conveyed to Richard Brasell & by him to me, also one other tract joining the above, Beginning at a small bush near a Gum tree at a bend of the creek & running thence N. 13. E. 12. ch. 50 links to a Stake thence, W. 5 ch. 50 links to a red oak near a branch (the beginning corner of the above tract) thence down the branch to the creek, and thence down the creek to the Beginning, containing Seven acres be the same more or less, the same being Part of the above mentioned tract granted to William Lynch & by him conveyed to David Hall & by him to Royal Pace & by him to John Glean and by him to me, Also one other tract joining the above Lands, Beginning at a forked chestnut near a branch and running thence N. 60 E. 26. Chain to a white oak, thence N. 15 ch. to a post oak, thence N. 50. E. 15 ch. to (post oak)
