State of South Carolina, Know all men by these presents that I Mattha Langford of Greenville District and State aforesaid, for and in consideration of the sum of one hundred and seventy dollars to me paid by Henry Langford of the State and district aforesaid, I Have granted bargained sold and released, and by these presents Do grant bargain sell & Release unto the said Henry Langford a tract or parcel of Land containing Two Hundred and twenty acres, only six excepted or there about that has been sold the balance more or less, Situate in Greenville District on both sides of the Long branch of fourth Tygar river, Beginning on a pine Robert Nelsons corner - running thence N. 40. E. 57. Chain with said Nelsons line, to a post oak, thence E. N. chain to a white oak, on the east bank of tygar river, thence N. 37 Degrees W. 40 chain to a Hickory on or near Howard's line thence South 43. N. 20 chain to a post oak thence South 86. N. 30 chain to a red oak thence along a conditional line to the mouth of a small branch that runs into the long branch on the south side thence up the small branch to Jeremiah Tubbs line, thence along said line to the Beginning corner, Together with all and singular the rights members
