on a dogwood the original line running N. 60. W. 16 ch. to a white oak 37  
thence N. 26. 22. ch 50 ch. to a red oak 37 thence N 49. E. 20. 50. to a stake 37  
near Warwick Bristers Hickory corner thence on said Bristers line to the  
Beginning, Estimated at fifty acres more or less, Situate in the District  
aforesaid on the waters of Mountain creek of Saluda river  
Together with all and singular the rights members Hereditaments &  
appurtenances to the said premises belonging or in any wise appertaining  
To Have and To Hold all and singular the premises before mentioned  
unto the S<sup>c</sup> Robert Scott his heirs and assigns forever, And I do hereby  
bind myself my heirs, Exec<sup>rs</sup> & administrators to warrant & forever  
defend all and singular the said premises unto the said Robert Scott  
(his heirs)
