 heirs and assigns all and every other Person, or Persons whatsoever - In Witness whereof

 four hundred Dollars of good and lawfull money of the United States to him
 in hand paid by the said party of the second part, the receipt whereof
 is hereby Confessed and acknowledged, Hath granted bargained sold com-
 firma, and by these presents doth grant bargain sell release & confirm
 unto the said party of the second part, and to their heirs and assigns one Negro man
 Neptune which I purchased from Sion Sanders, and my Negro girl Francis she being about
 thirteen or fourteen years of age, To Have and To Hold the said Negroes hereby re-
 leased and confirmed, unto the said party of the second part, their heirs and
 assigns forever, provided always, and these presents are upon this express condi-
 tion that if the said Jeremiah Shrother by his executors and administrators do and
 shall
