Foster. them their heirs and assigns forever the following mentioned negroes to wit, a negro woman Isabel a girl named Milly, and two boys named Joe & George now being in my possession which four negroes and their future increase I do warrant and will defend unto my said Children their heirs and assigns forever, to be Equally divided amongst them or the survivors of them whenever the youngest Child comes of age or marries, and the said Children are hereby authorized and empowered whenever the youngest as aforesaid comes of age or marries to take divide possess and enjoy the said Negroes and the increase of the female to them & their heirs and assigns forever. Witness my hand and seal this Twelfth day of December A.D. 1808.

Know all men by these presents that I Joab League of the County & State aforesaid, for and in consideration of the sum of twenty five dollars to me in hand paid by Elisha League of County & State aforesaid Have granted bargained and sold and released and by these presents do grant bargain sell and release unto the said Elisha League a parcel of Land supposed to contain fifty acres situate lying & being part in Greenville & part in Laurens Counties. Beginning on a stake on Joab League's line running S. 30. W. to a Stake on a line called Murph line thence along said Murph line to a Chestnut corner thence north to a Stake on S. Joab League's line thence along S. line to the Beginning corner Stake, Together with all and singular the Rights, members, dowers & Hereditaments and appurtenances to the said premises belonging or in any wise appertaining. To have & To hold singular the premises before mentioned unto the said Elisha League his heirs and assigns forever, and I Joab League do hereby bind myself my heirs Executors and administrators to warrant and forever defend all and singular the said premises unto the said of fifty acres be the same more or less it hap, unto the said Elisha League his heirs and assigns, against myself & my heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
