This Indenture made this twenty second day of October in the year of our Lord one thousand eight hundred and five and in the twenty ninth year of the American Independence
 between Isaac West Sen. of Pickens County and State of Tennessee of the one part and
 Isaac Green of Greenville County and State of South Carolina of the other part Whereas
 by a certain grant bearing date the twenty first day of January Anno Domini one thousand
 Seven hundred and eighty five from under the hand of his Excellency Ben. Grirard Eggn.
 Governor and Commander in Chief in and over the said State having the great seal of
 the State thereunto affixed being for that purpose appointed did give and grant unto the
 said Michael Johnson a plantation or tract of one hundred and sixty acres of land
 Situate lying on the waters of Pickens Creek a branch of Reedy River & hath such form
 and marks bating and courses as appear by a plat thereunto annexed which said
 plat and grant being duly Recorded in the Secretaries office Grant book 6666. Page
 251. Reference thereto being had may more fully appear, Now this Indenture
 witnesseth that the said Isaac West Sen. for and in consideration of the sum of
 Six hundred dollars current money of said State to him in hand paid and truly
 paid by the said Isaac Green before the sealing and delivering of these presents the
 Receipt whereof is hereby acknowledged, Hath granted bargained and sold and by these
 presents with grant bargain sell and convey unto the said Isaac Green the above
 described tract of Land, Together with the woods water hereditaments & appurtenances
 unto the said land belonging or in any wise appertaining. & Reversion & Reversions Remainder
 and Remainder Rent, issues and profits thereof. To have and to hold the aforesaid granted
 premises unto the said Isaac Green his heirs Exec. adm^r or assigns forever, and that the said
 Isaac West Sen. his heirs Exec. adm^r doth covenant and agree to and with the said Isaac
 Green his heirs Exec. adm^r or assigns shall at all times hereafter peaceably & quietly
 occupy possess and enjoy the aforesaid tract of one hundred and sixty acres of land lying and
 being as aforesaid from all former bargains sales mortgages judgments Rights of Doweries
 and all other incumbrances whatsoever and that the said Isaac West Sen. his heirs &
 executors will warrant and forever defend the aforesaid tract of one hundred and sixty acres
 of land unto the said Isaac Green his heirs Exec. adm^r or assigns from all and
