Have granted bargain sold and released and by these presents do grant bargain sell and release unto the said Joseph Williams all that tract plantation or Parcel of Land lying & being in Greenville District on branches of Saluda River, Beginning on a Stake Ogors line thence West to a Hickory Vincent Harrison's corner, thence his line to a Stake corner. Thomas Richardson, thence his line N 39 E 81 chains to a post oak, thence said Richardson's line to a pine, thence S 74 E 81 Ch^s a pine, thence N 35 E 21 chains to a stake, thence S 71 E 88 chains to a pine, John Swinstons corner, thence his line South 1/2 Ch^s 20 links to a red oak thence John Robinsons line to a Red Oak, thence S 25 W 16 Ch^s to a post oak, thence to the Beginning, Containing four hundred acres be the same more or less Together with all and singular the rights, members, hereditaments & appurtenances to the said Premises belonging or in any wise incident or appertaining, To Have & To Hold all & singular the said Premises to the said Joseph Williams his heirs & assigns forever, And I do hereby bind myself, my heirs Executors & adm^{rs} to warrant and forever defend all and singular the said Premises from myself, my heirs & against the lawfull claim of all persons whomsoever claiming any part or parcel thereof, In Testimony whereof I have hereunto set my hand and seal this 17th day of December & in the year of our Lord one thousand Eight hundred & Eight, & in the thirty third year of American Independence, Signed Sealed and delivered in Presence of

The State of South Carolina, Know all men by these presents that I Thomas Langford of Sumpter District and State aforesaid, in consideration of fifty Dollars to me paid by Joseph Williams of Greenville District and State aforesaid, Have granted bargain sold and released, and by these presents do grant bargain sell and release unto the said Joseph Williams all that plantation or tract of Land containing two hundred acres be the same more or less situate in Greenville District bounding on Saluda River Beginning on said river, on a black gum & ranging E 44 7/2 to a red oak, thence S 44 7/2 to a post oak thence W 44 7/2 to a stake & thence up said River to the Beginning, the said Land was granted to Daniel Langford the 2^d day of October 1786. by His Excellency William Moultrie, Together with all and singular the rights, members, hereditaments & appurtenances to the
